The Institute of Public Governance Completed 2020 Annual Inspection of the Functional Departments of PKU

In accordance with the requirements of Peking University, the Institute of Public Governance (IPG) has fulfilled the online filing work for 2020 annual inspection of the Office of Humanities and Social Science and passed the annual financial audit of the Peking University Education Foundation.

Under the requirements of the Office of Humanities and Social Science and the Peking University Education Foundation, and based on our review of all the research work and financial work in the past year, the IPG will continue its efforts on promoting an overall development by enhancing its research ability and management efficiency, striving to build a worldclass public governance research and think tank platform.

IPG Official Website Upgraded

In February 2021, the IPG further improved some functions under the columns of "Publications" and "Database and Case Center" on its official website.

After the upgrade, users can search by keywords and export forms data from the "Publications" and "Database and Case Center". Some other procedures have also been optimized and ten more databases have been added to the "Database and Case Center".

First IPG Management Committee Meeting in 2021was Held

The first IPG Management Committee Meeting of this year was held at Leo KoGuan Building on March 26, 2021. Director Jirong Yan, Deputy Directors Haiyan Li, Jie Yan and Huang Huang along with some administrative staff attended the meeting.

The meeting first reviewed and approved 14 general projects of the first quarter in 2021. In order to better support the research work of the School of Government, the committee decided that the application for general projects could be submitted at any time with no deadlines.

Then, they discussed the implementation plan of IPG key projects, which would be aimed to support team research and to build and cultivate high-quality academic teams. Key research areas were identified as well, including national governance, social governance and digital governance, etc.

In addition, the recipients of 2020 IPG research achievement awards were determined at the meeting. The meeting also discussed the 2021 plan including employing new researchers and holding academic lectures and so on.

The Jinrongjie Community Governance Project Team Held

Mid-Term Seminar

On March 25, 2021, the mid-term seminar on the Jinrongjie community governance project was held at Leo KoGuan Building. IPG Director and project leader Jirong Yan, Deputy Director Jie Yan and researchers including Yu Zeng, Gangsheng Zhang and some others attended the seminar.

At the seminar, the progress of the project was reviewed, and based on the previous investigation and multiple talks with Jinrongjie street administration office, two core topics were determined for the project, i.e. "Party Playing a Leading Role" and "Public Complaints Processed without Delay". It was also recommended that the project team should be transformed into a think tank and the Jinrongjie community work group should be established, the tasks of which might include: 1. to provide policy consultation and activity suggestions tailored for the specific needs of the Jinrongjie community; 2. to provide human resources; 3. to set up different key topics at each stage based on the research plan and form special research reports and academic papers; 4. to complete the overall research report and planning recommendation report.

General Projects Set Up in the First Quarter of 2021

Since the "Notice of Applying for 2021 General Projects at Peking University Institute of Public Governance" was issued, the Institute has received 14 applications, all of which have been approved according to the "Management Regulations of Peking University Institute of Public Governance Project". Each project shall be provided with 30,000 RMB research funding after establishment.

Research Achievements in 2021

Since January 2021, the "Special Project on the Covid-19 Prevention and Control" has produced two think-tank reports and published two signed academic papers. Among them, Mingzheng Xiao and Ruichao Zhang published "Risk Control Strategy of Returning to Poverty in China's Post-Poverty Era: Based on the Perspective of Risk Source Analysis and Human Resource Development" on the Journal of the Party School of the Central Committee of the C.P.C. (Chinese Academy of Governance), and Pengfei Wan and Xuemeng Liu published "Study on the Disaster Prevention Emergency Materials Management System in Tokyo Metropolitan" on the Administration Reform.
