### **The Institute of Public Governance of Peking University Held the 2021 Invited Experts Symposium**

On April 29th, the Institute held the 2021 invited experts symposium at Liao Kai Yuan Building. Former Peking University Council Chair Ren Yanshen, former deputy leader of leading group of central rural work Yuan Chunqing, former Beijing mayor Meng Xuenong, the former vice president of Beijing Organizing Committee of Olympic Games (BOCOG) Jiang Xiaoyu, former vice minister of the United Front Department of the CPC Central Committee Chen Xiqing, chairman of institute of state governance studies of Peking University Wang Puqu, director of the Institute Yan Jirong, and deputy directors of the Institute Yan Jie and Huang Huang attended the meeting. The meeting was chaired by the deputy director of the Institute Li Haiyan.

At the meeting, Yan Jirong reported the work progress of the institute since its establishment to the experts and introduced the key work deployment of the institute this year in detail.

The invited experts listened to the report and said full affirmation to the research work. Around the research and academic activities, they launched a heated discussion and put forward valuable opinions and suggestions about education and publish.

The symposium further expanded the breadth and depth of the institute's development, and had a long-term guiding significance for the development of the institute in the future.

### **Second IPG Management Committee Meeting in 2021 was Held**

On May 24th, the second IPG management committee meeting in 2021 was held at Liao Kaiyuan Building. Director of the Institute Yan Jirong, deputy director Li Haiyan, Huang Huang, Ju Hua and administrative staff attended the meeting.

The conference focused on key project team building, academic activity planning, electronic journal and other work.

The meeting discussed and proposed a list of key project team leaders, and emphasized that key projects should introduce a competition mechanism to ensure that the key project team has a clear research goal, and that the team has a reasonable structure of professional knowledge, title and age, so as to maintain the team's continuous innovation ability and development ability.

The meeting exchanged views on the content and scale of academic activities of key projects and stressed that academic activities should be continuous and innovative and strive to build a famous academic brand.

The meeting deliberated the samples of electronic journals, and put forward specific suggestions on topic classification, content setting, layout design, etc.

### **[The Jinrongjie Topic] The Institute Held a Series of Seminars on The Jinrongjie Community Governance Research**

- On April 8th, the first panel discussion of the Jinrongjie community governance research was held at Liao Kaiyuan Building. The dean of the school of government of Peking University and the total of the project YanJiRong, the deputy director of the Jinrongjie offices Hao Zhanjun, the vice president of the school of government of Peking university and the project group members YanJie, as well as some team members attended the meeting. The meeting listened to the recent research reports of each group, and analyzed and discussed the two core issues, that was party building guidance and responding to complaints, as well as the case base on community governance, digital governance and street system research. The problems found in the research were summarized, and the research

direction and entry point for the next step were defined. The meeting also made arrangements for the mid-term report and the next meeting.

- On April 15th, community governance research symposium was held in the Jinrongjie offices, Peking University team members Zeng Yu, Zhang Gangsheng and the deputy director of the Jinrongjie office Hao Zhanjun, the director of community building office Zhao Xinyu took part in the symposium. the two sides exchange ideas on party building guidance and responding to complaints. The meeting decided that follow research would focus on community mobilization and service for residents, focusing on 5-6 typical communities. The project team will continue to keep close contact with the Jinrongjie by sending interns and publishing research trends. It is expected that the research and observation of the project team will contribute to the innovation of the Jinrongjie community governance model and the shaping of community governance concepts. In addition, the Peking University team also had warm exchanges with the staff of The Jinrongjie Office on digital street governance and system construction, and further clarified the future research direction and ideas through communication.

- On April 22th, the second panel discussion of the Jinrongjie community governance research was held at Liao Kaiyuan Building. The dean of the school of government of Peking University and the total of the project YanJiRong, the vice president of the school of government of

Peking university and the project group members YanJie, the deputy director of The Jinrongjie offices Hao Zhanjun, and some team members attended the meeting both online and offline. The meeting listened to the recent research report of each group, and exchanged and discussed the next research direction of the sub-work of "Party building leading", "responding to complaints immediately" and "digital governance". The meeting also made arrangements for recent research, interviews, mid-term reports and other work.

- On May 7th, the third panel discussion of the the Jinrongjie community governance research was held at Liao Kaiyuan Building. The dean of the school of government of Peking University and the total of the project YanJiRong, the vice president of the school of government of Peking university and the project group members YanJie, the deputy director of the Jinrongjie office Hao Zhanjun, and some team members attended the meeting both online and offline. The conference focused on several topics such as Party building guidance, handling complaints immediately, digital street governance and case collection. The team put forward suggestions for the problems encountered in the research of the above issues, and had a heated discussion on how to mobilize and integrate party members and the executive-led consultation.

- On May 28th, to study and sum up the experiences of other street community governance, the Jinrongjie community governance research

members Zhang Gangsheng, Li Qinggang, Tong Tianyang investigate and survey de sheng street in Xi Cheng district. The chief of website intelligence office Zhao Pei, the chief of party leading office Yu Miao, and the informatization office Hou Jian took part in the discussion which was basically around Party building guidance, handling complaints immediately, digital street governance. Through this research, the project team understood the use of construction funds, the construction of grassroots party organizations, community building, and the intelligent method in garbage classification, epidemic prevention and control, pension services applications of the street and studied the innovation experience on party leading, active governance. In addition, the forum also discussed community governance issues such as vaccination, parking problems, property management committee, informatization development direction and difficulties in grassroots governance.

**[PKU Public Governance Lecture] Ren Yanshen | Peking University's Centennial Celebration and "985 Project"**

On May 11th, the first PKU Public Governance Lecture was held at Liao Kaiyuan building. Former Peking University Council Chair and council chairman of the institute Ren Yanshen had an in-depth exchange with teachers and students on the theme of "the centennial celebration of

Peking University and the 985 project".

Ren points out that knowledge innovation and talent development play an important role in economic development and social progress. From this perspective, it can be said that if there is no first-class university, there can be no first-class powerful country. Universities, especially elite ones, have a lot to do with the fortunes of countries. As an important educational center and scientific research center in China's modernization, Peking University shoulders the great responsibility of promoting the development of China's first-class universities.

During the preparation and organization of the centennial celebration, in order to better promote the discipline construction and serve the national construction, Peking University put forward the proposal of building a world-class university, which has been highly valued. The "985 Project" was officially launched in 1998 and has grown to 39 universities so far. Peking University also actively responded to the call to build a world-class university, actively raise funds, strengthen the introduction of talents, vigorously develop academic research, and has made rapid progress.

Ren points out that the centennial celebration is a great event in the history of Peking University and an important opportunity in the development. It not only enhances the international academic image of Peking University, but also draws great attention to Peking University and higher education. from people from all circles, including the alumni of

Peking University. The launch of the "985 Project", which has a deep connection with the centenary anniversary, provided impetus and resources for the development of PKU, and played an important role in the future development of PKU.

**[PKU Public Governance Lecture] Jiang Xiaoyu | The Leadership and Glory of the Communist Party of China Realize the Chinese Nation's Century-old Olympic Dream**

On May 28th, the second PKU Public Governance Lecture was held at Liao Kaiyuan building, the former vice president of Beijing Organizing Committee of Olympic Games (BOCOG) Jiang Xiaoyu had an in-depth exchange with teachers and students on the theme of "The Leadership and Glory of the Communist Party of China Realize the Chinese nation's Century-old Olympic Dream".

As an organizer and witness of the Beijing 2008 Olympic Games, Jiang vividly described the wonderful moments in the preparation, performance and competition of the Games.
